

RESOLUTION NO: 693

A RESOLUTION ABATING THE YEAR 2011 TAX LEVY FOR GENERAL OBLIGATION BONDS (ALTERNATE REVENUE SOURCE), SERIES 2011, AS AUTHORIZED BY VILLAGE OF LOUISVILLE ORDINANCE #678 PASSED AND ADOPTED JUNE 9, 2011

WHEREAS, the Village of Louisville has outstanding indebtedness in connection with projects as authorized by Ordinance No. 678, passed and adopted June 9, 2011, being an Ordinance entitled: “An Ordinance authorizing and providing for the issue of \$555,000 General Obligation Bonds (Alternate Revenue Source), Series 2011, of the Village of Louisville, Clay County, Illinois, and for the levy of a direct annual tax sufficient to pay the principal and interest on said bonds”; and

WHEREAS, it is the opinion and determination of the President and Board of Trustees of the Village of Louisville, Clay County, Illinois that for the year 2011 no real estate taxes need to be levied by the County Clerk for payment of any of the annual principal and interest which is due to be paid by the Village of Louisville pursuant to said Ordinance No. 678.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Louisville, of Clay County, Illinois, as follows:

Section 1: The President and Village Board of Trustees finds as facts the recitals hereinabove set forth.

Section 2: That there shall be no real estate taxes levied for the year 2011 (payable in 2012) from the levy provided in and imposed by Ordinance No. 678, the same being an Ordinance duly adopted by the President and Board of Trustees of the Village of Louisville, Illinois, a certified copy of which has heretofore been filed with the County Clerk of Clay County, Illinois.

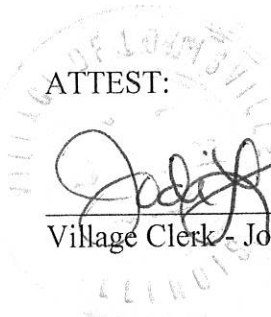

Resolution no later than the last Tuesday of December, 2011.





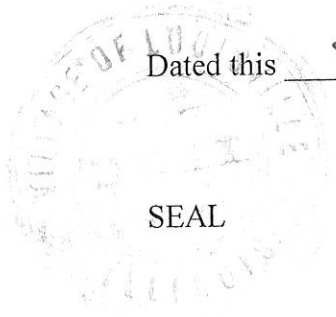
